**SPECIAL ORDER OF FOREST SUPERVISOR  
UINTA-WASATCH-CACHE NATIONAL FOREST  
PLEASANT GROVE RANGER DISTRICT**

**ALPINE SHOOTING AREA CLOSURE**

**PROHIBITIONS:**

Pursuant to Title 36 CFR 261.50 (a) and (b) **the following acts are prohibited in the National Forest System area as described in this order. The area affected is located on the Pleasant Grove Ranger District, Uinta-Wasatch-Cache National Forest. This order is in effect starting September 15, 2020 through October 15, 2020.**

- 1. Discharging a firearm, air rifle, or gas gun in or upon the area as described below and as shown on attached map. [36 CFR 261.53 (e)]**

**EXEMPTIONS:**

Pursuant to 36 CFR 261.50 (c) the following persons are exempt from this order:

- 1. Persons with special use authorization or other Forest Service authorization specifically exempting them from the effect of this Order.**
- 2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.**
- 3. Federal or State administrative personnel in performance of an official duty.**

**AREA DESCRIBED:**

**A 1200 foot deep (east/west) zone along the entire border (north/south) of U.S. Forest Service System land, Uinta-Wasatch-Cache National Forest, Pleasant Grove Ranger District where it meets Alpine city public or private land. This would cover the terrain from the fence-line to the tops of the first ridge looking eastward from the border located in Township 4 South, Range 2 East, Sections 8, 17, 20, and 29 all within the Salt Lake based Meridian as shown on attached map.**

**PURPOSE:**

Purpose of the Closure is to provide for health and public safety due to extreme fire conditions.

**IMPLEMENTATION:**

1. This Order will be in effect when signed September 15, 2020 and shall remain in effect until October, 15, 2020.
2. Attached map shows the areas affected by this Order.
3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization and/or imprisonment for not more than 6months imprisonment. [Title 16 USC 551, Title 18 USC 3571(b)(6), Title 18 USC 3581(b)(7)].
