**ASH CREEK SEWER SPECIAL SERVICES DISTRICT, DESIGNATION OF MAYORAL
REPRESENTATION TO THE ADMINISTRATIVE COUNCIL**

A RESOLUTION OF THE CITY COUNCIL OF TOQUERVILLE, UTAH, APPROVING THE DESIGNATION AND APPOINTMENT OF A REPRESENTATIVE TO SERVE ON THE ADMINISTRATIVE CONTROL BOARD OF ASH CREEK SPECIAL SERVICE DISTRICT FOR THE CALENDAR YEAR 2018 AND FOR SUCH TIME THEREAFTER UNTIL SUCCESSORS HAVE BEEN DESIGNATED AND APPOINTED.

WHEREAS Ash Creek Special Service District was created by the Washington County Commission for the purpose of providing wastewater collection and treatment services for the residents of Hurricane, LaVerkin and Toquerville, Utah, as well as other unincorporated areas of Washington County, Utah; and

WHEREAS said District is governed by an Administrative Control Board made up of six (6) members, two (2) of whom are appointed by each of the three aforementioned cities within the boundaries of the district; and

WHEREAS the City of Toquerville desires to designate the Mayor of Toquerville as a representative for the city of Toquerville on said Ash Creek Special Service District Administrative Control Board during the calendar year 2019, and for such time thereafter until successors have been appointed; and

WHEREAS all legal requirements pertaining to the designation of said representatives have been met; and


WHEREAS said City Council deems it necessary and desirable for the preservation of the public health, safety and welfare,

BE IT HEREBY RESOLVED by the City Council of Toquerville, Utah that Lynn Chamberlain, Mayor of Toquerville, shall be, and are hereby, designated to serve as the City of Toquerville's representatives on the Administrative Control Board of Ash Creek Special Service District for the calendar year 2018 and for such time thereafter until successors have been designated and appointed.
