**NO CHARGE, but Deposit fees may apply to the following:** Toquerville Public Agencies such as the City of Toquerville, & Toquerville Social and Welfare Activities such as Neighborhood Watch, Miss Toquerville Royalty, local churches, Boy Scouts, and Girl Scouts.

**REPLACEMENT**

NOTE: This Resolution will not repeal, abrogate, annul, impair, or interfere with existing provisions of other resolutions, ordinances, or laws, except to effect modification of the fees listed. The fees listed in this approved Schedule supersede present fees for the services specified, but all fees not listed remain in effect. Where this Resolution imposes a higher fee than is imposed or required by existing provisions of prior resolutions, the provisions of this Resolution shall control.
