HURRICANE VALLEY FIRE DISTRICT
REPRESENTATIVE APPOINTMENT

A RESOLUTION CONFIRMING THE APPOINTMENT OF A REPRESENTATIVE FROM THE CITY OF TOQUERVILLE, UTAH, TO THE CONTROL BOARD OF THE HURRICANE VALLEY FIRE DISTRICT AND PROVIDING FOR OTHER RELATED MATTERS.

WHEREAS said District is governed by a Control Board made up of members appointed by the various cities and towns within the boundaries of the Hurricane Valley Fire District; and

WHEREAS the City of Toquerville desires to designate a person to serve on said Control Board as the representative for the City of Toquerville during the calendar year 2018 or until such time that a successor has been designated and appointed; and

WHEREAS all legal requirements pertaining to the designation of said representative have been met; and

WHEREAS the City Council of Toquerville, Utah deems it necessary and desirable for the preservation of the public health, safety and welfare,

WHEREAS, appointment of a member from the City to the Control Board of the Hurricane Valley Fire District must be done by resolution of the City Council of Toquerville.

NOW THEREFORE, LET IT BE RESOLVED that the City of Toquerville, Utah designates Keen Ellsworth, a resident of Toquerville, shall be, and is hereby designated to serve as Toquerville's representative of the Control Board of Hurricane Valley Fire District Toquerville for the calendar year 2018 or until such time that a successor has been designated and appointed.


THIS RESOLUTION shall repeal and supersede all prior ordinances and resolutions governing the same that are in direct contradiction hereto, and

THIS RESOLUTION shall become effective immediately upon approval and adoption by the Toquerville City Council.
