RESOULTION 05-12-05 A 2005.05

A RESOLUTION OF THE TOQUERVILLE CITY CREATING AND OUTLINING THE DUTIES AND RESPONSIBILTIES OF THE MISS TOQUERVILLE PAGEANT COMMITTEE AND PARTICIPANTS.

WHEREAS Toquerville City Council desires to encourage participation for young ladies in a Miss Toquerville Pageant; and

WHEREAS the Toquerville City Councils desires to help inspire community service and good works;

WHEREAS Toquerville City Council desires to maintain consistency in the functions and duties of the Pageant Committee and Participants;

THEREFORE LET IT BE ESTABLISHED by the Toquerville City Council that a Miss Toquerville Committee shall be organized with the following provisions:

- A. Those desiring to hold the position of Miss Toquerville Pageant Director must be a current resident of Toquerville and apply to the City Council and be appointed by the Mayor with the advice and consent of the City Council. The term of the Director will be from the planning period of one pageant (usually in October) through the full year until the next pageant. The Director shall invite additional persons to serve with her with the consent and approval of the City Councilman assigned to oversee the pageant. Those invited members shall serve as an AD HOC committee for the current year. Committee members shall have demonstrated interest, competence or knowledge in pageant affairs
- B. The Director must not have a daughter, step-daughter or grand-daughter competing in the pageant the same year that she directs the pageant.
- C. Vacancies shall be filled for the unexpired term of any member whose term is vacant. Any member may be removed for cause by the City Councilman overseeing the pageant.

The members of the Committee shall serve without compensation; however, they shall be entitled to be reimbursed for any actual expenses by them in the performance of their duties from the Miss Toquerville Budget.

Committee Duties

The Committee Director shall have the following duties:

- The Committee Director shall call a meeting in the fall of each calendar year to plan for the pageant to be held in the early spring of the next calendar year and schedule as many planning sessions as deemed necessary.
- 2. To insure an invitation to each eligible young lady who resides within Toquerville City limits to participate in the Miss Toquerville Pageant.
- 3. To keep accurate record keeping of all expenses incurred by the Committee or Royalty; and to stay within the budget prescribed by the City Council each fiscal year.
- 4. To hold yearly at least one fund raising event with the Royalty to help off-set the cost of the Pageant.
- To oversee the Royalty at all required events.

- 6. To report to the City Councilman overseeing the Pageant any problems that may occur before, during or after the Pageant.
- 7. To make sure all the participants and/or Royalty abide by the Rules and Regulations for the Miss Toquerville Pageant.

The Committee members shall have the following duties:

- 1. Perform any duties the Chairman asks of you regarding the Pageant.
- 2. Report to the Chairman any problems with the Pageant Participants.
- 3. Give encouragement to each of the Pageant Participants.
- 4. Attend all required Pageant practices and or events including the Pageant, as assigned by the Chairman.
