# TOQUERVILLE CITY FEES ADMINISTRATIVE & PUBLIC WORKS SCHEDULE

Amending and Replacing Resolution #2006-1109R
Washington County Solid Waste (Trash) – Residential Increase

### **PURPOSE**

It is the intent of this Resolution to compile fees for City and Administrative Services, Licenses, Permits, Town Hall and Park Usage, Utilities, Cemetery, Public Works and all other related City costs. It is not intended by this resolution to repeal, abrogate, annul or in any way impair or interfere with existing provisions of other resolutions, ordinances, or laws, except to effect modification of the fees listed below. The fees listed in this Schedule supersede present fees for the services specified, but all fees not listed remain in effect. Where this Resolution imposes a higher fee than is imposed or required by existing provisions of prior Resolutions, the provisions of this Resolution shall control.
