A RESOLUTION OPENING AND AMENDING THE BUDGET FOR TOQUERVILLE CITY, FISCAL YEAR JULY 1, 2019 THROUGH JUNE 30, 2020.

WHEREAS, Toquerville City has reviewed its financial needs for the above fiscal year; and

WHEREAS, the City must amend the current budget in compliance with state law that sets forth revenues and expenditures for all fund types;

THEREFORE, LET IT BE RESOLVED THAT:

General Fund Revenues as budgeted shall be amended by

1. Moving \$10,000 from Line 10-60-710 Streets Construction/Capital New to 10-63-140 Trails Maintenance Supplies.
2. Moving \$4,500.00 from Line 10-64-900 Parks TRE Expense to 10-63-140 Trails Maintenance Supplies.
3. Moving \$10,000 from Line 10-66-135 Town Hall Supplies to 10-63-140 Trails Maintenance Supplies.
4. Moving \$5,000 from Line 10-45-300 Administration Professional Services to 10-62-360 Utility Collections Garbage Collection.
5. Moving \$10,000 from Line 10-65-710 Cemetery Capital Outlay to 10-64-100 Parks Wages.
