REPEALER. This resolution shall repeal and supersede all prior ordinances and resolutions governing the same.

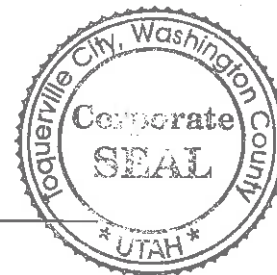
