**Full Member**      **\$100**  
 This membership is for one Home Club skater and includes USFSA membership, USFSA Skating magazine subscription, opportunities for exhibitions and shows, club activity and social event participation, club newsletter, and Club Ice (does NOT include Club Ice fees). One parent member is also included. Parent member and skating members over the age of 18 have voting rights and may serve on the Board of Directors if elected. Each family will have a maximum of 2 votes.

**Introductory Club Member**      **\$60**  
 This membership is for individuals who have never been a full or individual member of USFSA. They will receive a special discounted membership rate for one year only, and will be accorded all the benefits and privileges of a full member. No person can be an introductory member for more than one year, even if their membership lapses.

**Additional Skater**      **\$50**  
 This membership is for an additional Home Club skater who is an immediate family member of the Full Membership skater, and includes all of the benefits of a Full member except the USFSA Skating Magazine subscription and the voting privilege.

**Associate Second Club Member**      **\$40**  
 This membership is for those whose primary affiliation is with another USFSA Member Club. Associate members may participate in all club activities.

**Partial Year Member**      **\$50**  
 This membership is for members joining the Club after January 1<sup>st</sup>. Full Membership benefits apply.

**Supporting**      **\$20**  
 This membership is for supporting family members who are not skaters or professionals. Non-Skater members over the age of 18 have voting rights and may serve on the Board of Directors if elected. Also includes participation in club activities.

**Professional**      **\$40**  
 This membership is for professional coaches and USFSA appointed judges and includes USFSA membership, USFSA Skating magazine subscription, and participation in club activities. Proof of PSA membership and certificate of liability are required for professional coaches.

**Collegiate**      **\$70 (4 years)**  
 This membership is for competing skaters enrolled in college and includes USFSA membership, USFSA Skating magazine subscription, and participation in club activities.

Waiver and Release and Assumption of Risk Agreement*

In consideration of me being permitted to participate in any way in the **U.S. Figure Skating** and **Murray Silver Blades FSC** sponsored Activities ("Activity"), I agree:

1. **CODE OF CONDUCT**

Due to certain trends in youth sports whereby both parents and Members are letting their emotions manifest themselves in abusive and sometimes physical violence, the Murray Silver Blades FSC supports a zero tolerance policy for unsportsmanlike behavior. Its Members, coaches and parents (if Member is under 18 years old) should continually raise the standard of behavior – both on and off the ice.

Membership in the Murray Silver Blades FSC is a privilege and should carry a sense of pride. Participation in programs offered will require that members and parents (of Members under 18 years old) accept certain responsibilities.

**Members Responsibilities:**

I will not verbally or physically abuse any of my fellow members, other USFSA members, USFSA officials, club Board members, volunteers, or coaches.

I understand that poor sportsmanship, on or off ice, will not be tolerated.

**Parents/Guardian Responsibilities:**

I will encourage sportsmanship by showing positive support for all Members, coaches, Board Members and other officials during all on and off ice sessions.

I will encourage my child to treat all other Members, coaches, Board Members, other Member's parents and other officials with respect.

I will refrain from coaching my child or "manipulating" other Members during any on and off ice sessions.

I will not verbally or physically abuse any club Members (including my own child), coaches, club Board Members, officials, other parents, or volunteers.

I will represent myself positively and not undermine the authority of coaches, club Board Members, officials, or other club volunteers.

**Course of Action:**

*Should a parent or Member not adhere to the above, the Murray Silver Blades Board of Directors holds the Member and/or parent accountable and the Board of Directors is empowered to take necessary action. Actions could be as simple as a verbal warning to the parent or Member up to disciplinary hearings before the Board of Directors leading to suspension or expulsion from the Murray Silver Blades FSC.*
