

# 2018 Spring Show

## Solo & Duet Application

Performances: Friday, April 27th & Saturday, April 28th

The ice shows are directed and run by the Salt Lake County Ice Center with the assistance of the Murray Silver Blades Figure Skating Club. ### General 2018 Solo Rules and Information:

- Ice shows are for our skaters. Having fun and a great experience is and needs to be our top priority.
- All Skaters must be respectful to other skaters, ice center staff, parents, volunteers, and coaches. **We will not tolerate inappropriate behavior.** If show participants or parents choose not to abide by show rules, their solo/duet and/or group number will be forfeited.
- Parents (if skater is under 18) and skaters must sign the application stating that they have read and agree to all the terms of the show. By not signing or abiding by the rules, they will forfeit their solo/duet.
- If your solo/duet is forfeited or dropped due to not abiding by the 2018 Spring Show rules, the Salt Lake County Ice Center is not subject to issuing a refund.
- Must be a Full or Secondary club member of the Murray Silver Blades FSC and in good standing.
- Must be in good financial standing with the Salt Lake County Ice Center and MSBFSC.
- Duets will be considered as solos, and will follow Solo rules.
- The total number of solos/duets for the 2018 Spring Show will be determined by the length of the entire show (no more than 80 minutes) minus Club and LTS group numbers, and guest skaters. There will be two types of solos/duets: Test Level and Wild Card (see below).
- All soloists **must** participate in a MSBFSC group number, and follow all group number rules. If a soloist is unable to meet the requirements for a club group number they will lose the opportunity to skate in both the group number and their solo. Exceptions may be made for collegiate skaters and high school seniors of MSBFSC.
- All secondary members (pre-preliminary and above) will be considered wild cards regardless of level. Primary members will have first priority when choosing the wild card solos and duets.
- Skaters can be in a maximum of three show numbers. More than three will result in losing their solo/duet.
- Placement in the show is determined by a number of factors. County staff will try to accommodate special requests but is not subject to reworking the skating order.
- Submit this application by **Tuesday, March 6, 2018** to the Salt Lake County Ice Center Front Desk. **Late applications will NOT be accepted.** Please complete this application *in its entirety*.
- **Dress Rehearsal is Wednesday, April 25<sup>th</sup> (specific time to be determined).**

### **Test Solo Qualifications:**

- To qualify for a Test Solo, skaters must have passed their Juvenile Free Skate test by **Tuesday, March 6, 2018** (regardless if they are collegiate skaters), follow all general 2018 solo/duet rules, and pay their fee to the front desk by **Tuesday, March 13.**

### **Wild Card Solo Qualifications:**

- Wild card solos/duets are chosen at random during the wild card drawing (**Tuesday March 13**, during club ice). The total number of wild card solos/duets available will be divided equally between each level depending on wild card applicants.
- To be eligible for a Wild Card solo, skaters must have passed their Pre-Preliminary Free Skate test by **Tuesday, March 6** (regardless if they are collegiate skaters) and follow all general 2018 solo/duet rules.
- Only one solo will be allowed per skating season unless there is space available. Wild Card solo fee of \$25.00 and duet fee of \$15.00 per skater are to be **paid after the drawing.**

### **Music Qualifications:**

- Solo music has been chosen to fit within the theme. Highest test level skaters will get first choice. You will meet with Jill Ferrier individually on Tuesday, March 13 during club ice. At that time you will choose a song from the pre-approved list. Music will be cut and provided for you.
- Application and fees **MUST** be submitted to the Salt Lake County Ice Center prior to reserving for solo music. Solo fee is \$25.00 per skater & duet fee is \$15.00 per skater.

**Parental Statement of Agreement, Assumption of Risk, Liability and Refund Policy**

**1. Release and indemnification:** I hereby recognize and acknowledge that my child's participation in recreational activities may involve bodily and/or emotional injury to myself and/or my child. In consideration of my child being able to participate in such events I for myself, my child, my heirs, my executors and administrators, hereby voluntarily and knowingly indemnify and hold harmless, defend, release, waive and discharge Murray Silver Blades FSC and/or Salt Lake County and its officers, employees, and volunteers from any and all suits, claims or liabilities, including negligence based on any injury except that caused solely by the willful misconduct of Murray Silver Blades FSC and/or Salt Lake County, that may result from my child's participation in Murray Silver Blades and Salt Lake County Parks and Recreation activities. In addition, I agree that I or my insurance company will pay for medical, hospitalization or any other expenses resulting from my child's participation.

**2. Refund Policy:** As per Murray Silver Blades and/or Salt Lake County policy and procedures, the Parks & Recreation Division may withhold 25% of the refund (program registration fee) for administrative costs. All refunds must be requested in person and accompanied with a written refund request. No refunds shall be given after the first day of the program.

**3. Collections:** I agree to pay Murray Silver Blades FSC and/or Salt Lake County all costs incurred, together with reasonable attorney's fees in the event that my account is referred to the Murray Silver Blades FSC and/or Salt Lake County Attorney's Office for collection. I understand that any account delinquent 30 days or more will be turned over to the Murray Silver Blades FSC and/or Salt Lake County Attorney for collection.

**4. Emergency Treatment:** I hereby authorize Murray Silver Blades FSC and/or Salt Lake County Parks and Recreation program staff to act on my behalf in accordance with their best judgment in case of an emergency involving my child, and agree to assume full responsibility for all expenses, medical or otherwise that may arise there from. I understand that I or my insurance company will pay for such emergency treatment.

**5. Equal Opportunity:** Murray Silver Blades and/or Salt Lake County Parks & Recreation provide equal opportunity to participate regardless of race, creed, gender or ability to pay and will, upon request provide reasonable accommodations to individuals with disabilities.
