COMPENSATION OF ELECTED AND APPOINTED OFFICERS AND CITY EMPLOYEES
Amending and Replacing Resolution #RES.2011.06

PURPOSE: This Resolution provides for Compensation of all Toquerville City Elected and Appointed Officers and City Employees.

WHEREAS, the number of duties assigned to each elected and appointed officer has increased significantly and each elected offices is required to devote more time to the effective administration of Toquerville City; and

WHEREAS, public service obligates elected officers to spend their own money in the service of Toquerville City; and

WHEREAS, elected and appointed officers should be fairly compensated for their time and expenses;

THEREFORE BE IT ORDAINED BY THE TOQUERVILLE CITY COUNCIL THAT:

1. Compensation: The monthly compensation of the elected and appointed officers shall be as follows:

a. Mayor	\$1500.00
b. Councilmen	\$ 200.00
c. Treasurer/Clerk	\$12.00 to \$20.00 per hour range
d. Recorder/Clerk	\$12.00 to \$20.00 per hour range
e. Maintenance	\$12.00 to \$20.00 per hour range

2. Payment: The Treasurer shall pay each of the above named City positions on the second Thursday of each month for the work performed the previous month by delivery of a check drawn on the municipal checking account to the person to which the monies are entitled. City Employees shall be paid twice per month.

3. Per Diem: Each member of the governing body shall receive mileage and per diem for all trips approved by the governing board according to the schedules adopted by the Utah Department of Finance.

4. Sunset Clause: The Compensation of the Mayor shall Continue as agreed upon in Resolution 2011.06 as \$1500.00 per month, until the end of term, December 31st, 2016, and then shall be \$1000.00 beginning January 1st, 2017, and remain so until vote of the Council.

THIS RESOLUTION shall repeal and supercede all prior ordinances and resolutions governing the same that are in direct contradiction hereto, and

THIS RESOLUTION shall become effective immediately upon approval and adoption by Toquerville City Council on the 10th day of April 2014.
