Mayor Jones welcomed everyone and called the meeting to order at 7:00 PM. Everyone stood for the Pledge.

Councilwoman Faux gave invocation.

Mayor Jones called for any addenda to the agenda and there were none.

CONSENT AGENDA

Councilman Heward made a motion to approve the bills, payroll and the minutes of the November 26th, 2024 regular council meeting. Councilman Wardle seconded and the motion carried.

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF RUPERT IDAHO, FINDING AND DECLARING PROPERTY IN RUPERT, IDAHO TO BE A DETERIORATED AND DETERIORATING AREA AND REQUESTING ACTION OF THE RUPERT URBAN RENEWAL AGENCY.

Item: A. PUBLIC HEARING – Creating of Industrial Wastewater Utility Rates and Creation of Electric Department Solar Application Fees

City Administrator, Kelly Anthon, explained that the City had previously only addressed industrial wastewater fees through contract agreement. The City was now establishing set fees.

Also, being proposed was an increase to electrical service rates, which had not gone up in two years, in an amount less than four percent. There were also new fees being created to go along with the solar metering application process.

Mayor Jones opened the public hearing at 7:18 PM.

Keith Goodsell – Asked if the rate was to be in place of the industrial rate contracts or as a fallback if necessary.

It was explained that the rate would be in place if industrial wastewater agreements were not executed and kept.
