

Official Sweepstakes Rules for the 2015 Sport Court #OfficialCourt NCAA® Women's Volleyball Sweepstakes

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

Binding Agreement

Participation in the "2015 Sport Court #OfficialCourt NCAA® Women's Volleyball Sweepstakes" (the "Sweepstakes") constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of Sponsor (as defined below), which are final and binding. Winning a prize is contingent upon fulfilling all requirements set forth herein. The Sweepstakes is sponsored by Sport Court, 5445 West Harold Gatty Drive, Salt Lake City, UT 84116 ("Sponsor"). Therefore, please read these Official Rules prior to entry to ensure you understand and agree. These Official Rules form a binding legal agreement between you and the Sponsor with respect to the Sweepstakes. The National Collegiate Athletic Association ("NCAA")* is neither a sponsor nor administrator of this Sweepstakes.

Odds

The odds of winning a prize will depend on the number of eligible entries received.

Who Can Enter

To be eligible to participate in this Sweepstakes, at time of entry entrant must be a legal resident of, and physically located within any, of the 50 United States and the District of Columbia, and over the age of 13, and, if under the legal age of majority within entrant's state of residence (18, except for Alabama and Nebraska where the legal age is 19, Mississippi where the legal age is 21) at time of entry must enter with the help and approval of their parent or legal guardian. If the Sweepstake winner is under the age of majority within their state of residence, Sweepstakes prize will be awarded to parent(s) or legal guardian(s). All directors, officers, and employees of Sponsor, and those of its affiliates and Sweepstakes agencies, the NCAA, or current NCAA student athletes, and each of their immediate family members (spouses, parents, children, and siblings and their respective spouses), and those living in the same household as each, are not eligible to participate in this Sweepstakes. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations. Void where otherwise prohibited.

Sweepstake Period

The Sweepstakes begins on 12/9/15 at 12:00:01 am Mountain Standard Time

("MT") and will end on 12/19/15 at 11:59:59 pm MT (the "Sweepstakes Period"). The Sponsor's computer system shall be the official timekeeper.

How to Enter

To enter Sweepstakes, during the Sweepstakes Period, entrants visit their personal instagram or twitter account and post a story/video/photo that shows what it means to them when they step onto the volleyball court. Each photograph or video must be accompanied by the tag #OfficialCourt. Entrants may submit an unlimited number of Entries. Entrants represent and warrant that their Entries are the original works of such entrant, have not been copied from others, and do not violate the rights of any other person or entity. All entrant information, including e-mail addresses, is subject to the respective Privacy Policy of the Sponsor. All entries become the property of Sponsor and will not be acknowledged or returned.

Random Drawing

One (1) grand prize winner and six (6) second prize winners of the Sweepstakes will be selected at approximately 12:00 pm MT on 12/19/15 from all eligible entries received during the Sweepstakes Period. The potential winner will be notified by social media. If the potential winner declines in writing to accept a prize, prize or prize notification is returned as undeliverable, the Sponsor is unable to contact a potential winner within a reasonable time period, or a potential winner is not otherwise in compliance with these Official Rules, the prize will be forfeited and, at the Sponsor's sole discretion and time permitting, it may select an alternate winner from all remaining eligible entries. Prizes will be fulfilled approximately twenty (20) business days after the conclusion of the particular drawing. Limited to one (1) prize per household. The decisions of Sponsor are final and binding on all matters relating to this Sweepstakes.

Prizes

One (1) winner will receive a framed replica NCAA® Women's Volleyball Sport Court volleyball court and six (6) winners will each receive one (1) Official NCAA® Sport Court commemorative tile. **Approximate retail value ("AVR") of framed replica is \$500. AVR of each prize commemorative tile \$20. Total ARV for all prizes is \$1,700.** Prizes will be awarded "as is" with no warranty, guarantee or representations, either express or implied by Sponsor. If required by law, Sponsor reserves the right to withhold and remit to the appropriate taxing authorities the amount of any taxes due. The winner is fully responsible for any and all applicable federal, state, and local taxes. All costs and expenses associated with prize acceptance and use not specified herein as being provided are the sole responsibility of the winner. Prizes are non-transferable and non-assignable, with no cash redemptions or substitutions except at Sponsor's sole discretion. Conditions/Use Rights

Privacy

Sponsor is dedicated to protecting the privacy of contestants and will never sell or distribute contestant information to any third party. We use the information entered (name and email address) as a means for contacting Sweepstakes winners. We may also use such information to mail you promotional and marketing material from our business, but will never sell, distribute or publish such information.

Release and Limitations on Liability

By participating in the Sweepstakes, entrants agree to release and hold harmless Sponsor, the NCAA, and their respective parent companies, subsidiaries, affiliates, sales representatives, distributors, licensees, agents, advertising and Sweepstakes agencies, and all directors, officers and employees of all of the foregoing entities (the "Released Parties") from and against any claim or cause of action arising out of participation in the Sweepstakes, or receipt or use of any prize, including, but not limited to: (a) unauthorized human intervention in the Sweepstakes; (b) technical errors related to computers, servers, providers, or telephone or network lines; (c) printing errors; (d) lost, late, misdirected, incorrect, garbled, or incompletely received entries; (e) errors in the administration of the Sweepstakes or the processing of entries; (f) injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or acceptance, receipt, use, or misuse of any prize; or travel to any Sweepstakes-related events; and (g) any claims based on publicity rights, copyright/trademark infringement, intellectual property rights, defamation or invasion of privacy and merchandise delivery. Miscellaneous

Entrants specifically agree that (1) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the District of Utah or the appropriate Utah State Court located in Utah County, Utah; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. ENTRANT HEREBY IRREVOCABLY CONSENTS TO THE PERSONAL JURISDICTION OF SAID COURTS AND WAIVE ANY CLAIM OF FORUM NON-CONVENIENS OR LACK OF PERSONAL JURISDICTION THAT ENTRANT MAY HAVE. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process, the operation of the Sweepstakes, to be acting in violation of these Official Rules or any applicable laws relating to the Sweepstakes, or in an unsportsmanlike or disruptive manner, and to resolve all disputes in its sole discretion. Any attempt by any person to undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's

failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
