For years, you have hidden money in your Paris fund and hordifying sick days for the journey of a lifetime. The goal is to eat as many baguettes as possible and drink as many cups of coffee au lait in as many sidewalk cafes as possible. While you can check out the Louvre, this trip is about experiencing the royal Paris of quiet cobbled side streets and small neighborhood bistros. But where to stay? Good hotels in your favorite Parisian neighborhood — Saint-Germain-des-Prés — average more than \$300 per night. This will burn your Paris fund in days. Wouldn't it be better to experience the real Paris by staying at the home of a true Parisian? With Airbnb, you can rent a bedroom, apartment, house and the occasional castle in 34,000 cities around the world directly from the people who own them. In fact, there is a beautiful studio apartment in Saint-Germain-des-Prés for only \$145 a night. Better yet, its host, Edouard, is happy to tell you about the best confectioneries, bars and art galleries at a distance from his studio overlooking the Luxembourg Gardens. Oui, sir! When Airbnb was launched in 2008, the site hosted a handful of apartments in New York. By 2014, Airbnb visitors could search more than 600,000 listings in 192 countries. The business model is simple: connect local hosts with visiting tourists and charge a small fee for the service. With more than 50,000 bookings per night, some analysts value the private company at \$10 billion [source: Konrad]. Airbnb began in 2008, when co-founders Brian Chesky and Joe Gebbia launched a website to rent two airbeds in their San Francisco apartment during a conference to earn some extra money. (Hence the name of the site, which represented airbed and breakfast). The popularity of the site caught even the co-founders by surprise. At first, we thought, you'd only stay there because it was cheaper, Chesky told the Atlantic in 2013. But that was such a wrong assumption. People love houses. That's why they live in them. If we wanted to live in hotels, more houses would be designed as hotels. Not surprisingly, hotels are some of the site's most vocal detractors. They, along with city owners and governments, accuse Airbnb users of circumventing rental laws and soenforcement taxes. Kitty Mrache/Airbnb The most popular rental on Airbnb is not this pied-à-terre in Le Marais, or this dreamed hilltop village in Tuscany. According to the Guardian, the mushroom cap has surpassed the most glamorous rentals since it was first listed on Airbnb seven years ago. The massive round, led by U.S. growth stock firm General Atlantic, would value Airbnb at \$24 billion. Like uber (and many others airbnb's prospective growth depends on its expansion into Asian markets. Airbnb has long been said to be one of the next major IPOs in the technology industry, and this reported assessment only raises this speculation. As the Financial Times points out, this round would correspond to the \$1.5 billion Facebook raised just a year before it spread in 2012. Since its founding in 2008. Airbnb has slowly begun to disband the dominance of traditional hotels, which are left struggling to figure out how to court budget-conscious and travel-hungry millennials. The travel industry is huge, and there's plenty of room for Airbnb's market share and name recognition to grow. Disrupting a well-established \$6 trillion industry is not a simple undertaking, but a new infusion of money should help. Airbnb wants U.S. mayors to know that their cities can profit from the home rental business. The startup, which is now the world's largest hospitality company based on its number of listings, released a report at the U.S. Conference of Mayors' winter meeting this week that estimates that the 50 largest cities in the United States would earn \$2 billion in Airbnb tax revenue over the next 10 years -- if they worked with Airbnb to collect taxes on hotels and occupancy taxes in at least 14 U.S. cities, including San Francisco, Portland and Chicago, and in four states. The company says it would have referred \$42.6 million in such taxes globally, but if it had collected taxes in all cities, that number would have been much higher. In 2015 alone, the company says, it reportedly sent \$200 million to the top 50 cities in the United States. Hosts on Airbnb doesn't collect and remit them, but as you can imagine, individual compliance varies. Airbnb may collect taxes on each booking. Airbnb has often used its potential to generate tax revenue as an incentive for cities to allow it to operate freely. As he asks The City of New York to change laws that prohibit him from collecting hotel taxes, for example, he has publicly released not one, but two estimates of how much money such a policy would generate. When he faced a proposal in San Francisco that threatened to limit his business, he pointed out that restricting Airbnb would cost the city \$58 million in tax revenue. it seems easy for all cities to work with Airbnb to collect these taxes —doesn't everyone like money? But many cities prohibit home rentals Less than 30 days, and authorities fear that changing laws to allow Airbnb to collect taxes would legitimately be an essentially illegal business. This is just an effort by Airbnb to strengthen its image by ignoring local laws that they find inconvenient, Said New York State Senator Liz Krueger in a statement to Slate. Paying hotel taxes actually puts the 'hosts' who they claim care so much about the risk of eviction, providing evidence of rental violations, and does nothing to alleviate an acute shortage of affordable housing that their illegal activity exacerbates.
